The Tender(s) should state:

- (a) Whether he is related to any member of the staff working at this farm and if so, what is the relationship:
 - (b) Whether he pay any Income Tax and if so, should furnish the Income Tax Payment Certificate.
 - (c) Whether he has taken any works in the Central Poultry Development Organisation (ER), Bhubaneswar in the past and if so, the name of the works and the year in which it was taken.

Tenders / Quotations can be obtained on payment of Rs. 1000/- each (RS. 100/- extra for postal charges) from the office of the Director, Central Poultry Development Organisation, (ER) Bhubaneswar either by letter or on personal application between 10.00 A.M to 3.00 P.M on any working day upto 10.08.2016 and must be submitted in the strong cover securely fastened with a distinctive, device and conspicuously marked “INSTALLATION OF AUTOMATIC FEEDING & NIPPLE DRINKING SYSTEM IN POULTRY SHED, FARM UNIT - II” addressed to the Director, Central Poultry Development Organisation (ER), Government of India, Bhubaneswar – 751012 and not to any officer by name. Tender / Quotation will be received upto 3.00 P.M. on dt. 10.08.2016.
 3. Documents can be downloaded from our website www.cpdobbsr.in / www.eprocure.gov.in and the payment of Rs. 1000/- must be attached with the tender / quotation document.
 4. Tenders will be opened by the Director, Central Poultry Development Organisation (ER), Bhubaneswar on the 10.08.2016 at 3.30 P.M in the presence of such Tenderers as desired to be present. The tenders shall remain open for acceptance till acceptance letter send.
 5. Each tender must be accompanied by a deposit of Rs. 60,000/- (Rupees Sixty thousand only) as EARNEST MONEY in forms of:

FDR / TDR of any Nationalised Bank to be pledged in favour of Director, CPDO, Bhubaneswar.

6. **Earnest money of successful tenderer(s) will be returned after successful completion / installation of Automatic Feeding & Nipple Drinking System and that of unsuccessful tenderer(s) will be returned to them as soon as possible.**
7. **If the 1st lowest tenderer fails to undertake the work within the stipulated time, then the 2nd lowest tender may be accepted if Purchase Committee agreed to.**
8. **The lowest or any tender will not necessarily be accepted, and the Director reserves the right to reject any or all tenders or to accept any tender in part without assigning any reason whatsoever. Acceptance of a tender does not prevent the acceptance of other tenders as well.**
9. **This “Call for tenders” form also must be signed by the tenderer (s) and returned with his / their tender(s).**
10. **The Signature(s) of the tenderer(s) on the tender and other forms must be attested by two reputable witness in the space provided for the purpose on the last page of the tender and other forms. **CONDITIONAL TENDERS SHALL NOT BE ACCEPTED.****
11. **As required under Section 194 – C of the Income Tax Act 1961 (43 of 1961), Income Tax @2% will be deducted in all cases of Payments exceeding Rs.10, 000/- plus Education Cess 3% on I.T.**

- 1. I / we, the undersigned, agree on the acceptance of this tender to deliver to the President of India(here in after referred to us “The Government” which expression shall include these duly authorized to act of or him), in accordance with such acceptance, so many / much many of the article / services specified in the schedule attached here to as the Director, Central Poultry Development Organisation (ER), Bhubaneswar “specified in this tender (including any schedules and specification and conditions” contained therein and attached hereto), in the acceptance or in the “Call for Tender” (all of which constitute and are here in after referred to as the contract).**
- 2. All money or compensation payable by me / us to the Government under the terms of contract may be deducted from the earnest money deposit or from the interest arising there from, or from any sums which may be due to may become due to me / us by the Government under this or any other account. If insufficient, the balance shall be paid on demand.**
- 3. The Government may rescind this contact by two weeks notice to me / us in writing.**
 - i) If I / we assign, or sub – let my/ our contract without their approval of if I / we attempt to do so.**
 - ii) If I / we decline neglect or delay to comply with any demand or requisition or in, any other way fail to perform or observe any condition of the contract or are in the opinion of the Government which shall be final, not likely to carry my / our the contract satisfactory.**
 - iii) If I / we or any of our partner become insolvent or apply for relief as an insolvent debtor (s) may any composition with my / our creditor or attempt to do so.**
 - iv) If I / we or any of my/ our agent (s) or servant(s) shall (a) be guilty or fraud in respect of the contract or any other contract entered into by me / us with the**

Government or (b) directly or indirectly given promise or offer any bribe, gratuity, gift, loan, perquisite, reward or advantage pecuniary or otherwise to any officer or person in the employment of the Government in any way relating to such officers or persons office or employment or attempt to do so.

- v) **If any such officer or person mentioned in clause – 8 (iv) becomes in any way directly or indirectly interested in the contract.**

In case of such rescission my / our earnest money deposit shall stand forfeited and be absolutely at the disposal of Government without prejudice to any other remedy or action that the Government may have to take.

4. **Not – with – standing anything there in before contained and without prejudice thereto, the Government may recover from me / us compensation such sums are as they, at their discretion, which shall be final, may consider reasonable.**
- (i) **If any Government property entrusted to me / us under the contract be lost, damaged or depreciated, unless such loss damage or depreciation be due to an act of God or of the Nations enemies.**
 - (ii) **If any damage be done to the Government’s or other property from any cause whatsoever arising through the action of myself/ourselves, either my/our servant(s)agent(s) or employees.**
 - (iii) **If I / we fail to observe or perform any condition of the contract.**
5. **Receipts of supplies delivered will be supplied to me/us by the Government at the time of delivery and I / We shall submit on the first day of the following month in duplicate duly support by these receipts as sub – vouchers my / our bill in English or all supplies duly accepted and payment will be made to me/us as soon as possible at a Government treasury or otherwise at the discretion of the Government.**
6. **My/ our earnest money deposit or the balanced thereof, if any remaining thereof, if any remaining at the end of the contract after the penalties imposed if any, under clause – 7,8 and 9 above have been adjusted shall not returned to me/us until I / We have executed the usual “ NO DEMAND CERTIFICATE”.**
7. **I / We acknowledge that I / We have made myself / ourselves fully acquainted with all the condition and circumstances under which the supplies under the contract will have to be made or furnish and with all the terms, clauses, conditions, specifications and other details of the contract and I / We shall not plead ignorance of any of these excuse in case of complaint against or rejection of supplies tendered by me / us or with a view either to ask for enhancement of any rates agreed to in the contract or to evading any of my / our obligations under the contract.**

- 9. Any disputes arising in tender should be within the legal jurisdiction of the High Court of Orissa.**

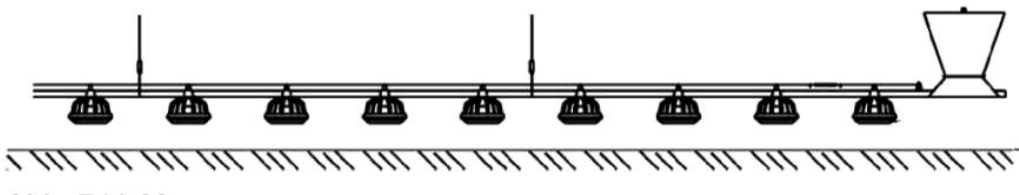
SCHEDULE OF REQUIREMENTS AND SPECIFICATION (TECHNICAL DETAILS) FOR INSTALLATION OF AUTOMATIC FEEDING & NIPPLE DRINKING SYSTEM IN POULTRY SHED, FARM UNIT - II.

Tenders / Bidders are advised to study carefully the various clauses content in the special terms and conditions before submitting their bids. Firms willing to participate in the tender may also visit CPDO(ER), Bhubaneswar and acquaint themselves with the nature and quantum of work involved before submitting the bids. All the information as required in the tender document should be filled up in the relevant part and no column should be left unfilled. An incomplete tender / document submitted without the earnest money deposit will be summarily rejected.

(A) Automatic Pan Feeding System: should consist of Hopper (s) with feed intake boot(s). The pans should be made up of Polypropylene and galvanized tubes (2.95 /3.05) with clamps and auger having sensor and antiperch cable. It should also include classic standard pans , appropriate strut grills , support cones, tops supports, short adjusterings , steel cable suspension etc. system should be capable to provide restricted feeding with equal quantity, simultaneously all over the house. Provision of Control Panel for automatic / manual operation including Feed Registration and present quantity of feed facilities.

i) Feeding System – Technical Specifications:

No. of Feeding line – 3, Tubes per line – 9, Tube length – 3.05 m, Pans per tube – 4, No. of fill point per line – 1, Fill point position – Front, No. of pans per line – 27, Circuit filling – flex – Auger front winch system. Systems should not allow to sit birds on the pipe.



(B) Automatic Nipple Drinking System: should consist of stainless steel 360° nipples, filter, appropriate support profile, front winch system, steel cable, other fabrication work, pulley etc. the system should capable to provide medicine with equal distribution, appropriate pressure on each nipple.

i) Nipple Drinking System - Technical Specification :

No. of Drinking line -4, Number of PVC Pipe per line– 9, Pipe Length – 10', Nipples and drip cup per pipe – 10, No. of pressure regulator – 1/ line , Position of pressure regulator Front, Pressure indicator per line – 8, Specification of the pipe – Square 0.5", Front Winch system , Systems should not allow to sit birds on the pipe.

- 4) Installation of above system to be done on turn key basis.
